The Consolidated Appropriations Act, 2021 and the American Rescue Plan Act of 2021 provided funds to states to administer a Low-Income Household Water Assistance Program (LIHWAP). The benefit program year is through September 30, 2023. A state plan is necessary to delineate the program benefits, eligibility criteria, and other policy in the Water and Sewer Assistance Program (WSAP), administered by the Division of Welfare and Supportive Services. States must submit a State Plan to the Administration for Children and Families (ACF), Office of Community Services (OCS), which serves as an application for funds.
