## DIVISION OF WELFARE AND SUPPORTIVE SERVICES SMALL CHILD CARE ESTABLISHMENT REGISTRATION INFORMATION

#### AB 346: Updated provisions, NRS 432A.024

"A person, state or local government unit or agency thereof that wishes to operate or operates a small child care establishment (SCE) may\* register the small child care establishment with the Division of Welfare and Supportive Services (DWSS)" and submit certain information to DWSS regarding employees and certain residents of the SCE.

This bill makes the background check processes for licensed centers applicable to operators, employees, and certain residents of SCEs that are registered with DWSS. The operators must also maintain records of these mandatory background checks. Similar to the background check processes, registration also opens the SCE up to inspections by the Division of Public and Behavioral Health (DPBH). Violations of required regulations are also subject to fine(s) by the DPBH.

DPBH is authorized to inspect any facility or outdoor youth program to secure compliance with or prevent a violation of applicable law. This bill makes this authorization applicable to SCEs, whether they are registered or not. If a complaint against a child care facility or a SCE is substantiated, the bill authorizes DPBH to collect from the facility or SCE the costs of the DPBH relating to the violation, including the costs of any necessary inspections or investigations.

\*may = Unlicensed establishments which furnish care to no more than four children under 18 years of age who are not related to the operator are not "required" to register, though per the updated Bill provisions, are "authorized" and "may" do so.

## **DPBH & DWSS Child Care and Development Program**

Per the contents of AB 346, the registration of small child care establishments will be a collaborative effort between the DWSS Child Care and Development Program (CCDP) and the DPBH. #### **Subsidy Program Eligibility**

As the Lead Agency in Nevada, the DWSS Child Care and Development Program (CCDP) sub-grants funding to community entities, The Children's Cabinet and The Las Vegas Urban League, from the Child Care and Development Fund (CCDF), and in accordance with the Child Care and Development Block Grant Requirements.

Prospective or current providers of child care for between one and four children who are considered family, friends, or neighbors may qualify to participate in the CCDP subsidy program for this service.
