A-134	<b>Rights and Responsibilities</b> -From number updated for Good Cause with Child Support Enforcement.	
A-160.1	<b>Quality Control (QC) Cooperation</b> -Section updated to clarify the period of ineligibility for households who are not in cooperation with Quality Control.	E&P PT 02-15
A-330	<b>Who is Included</b> – SNAP side updated to include spouses in same sex marriages and domestic partners as required household members. These individuals cannot be separate from their spouses and/or domestic partners.	E&P PT 04-14 E&P P&P 18-14
A-335	<b>Authorized Representatives</b> - section updated to clarify that individuals currently serving a disqualification for an Intentional Program Violation are banned from serving as an AR unless the agency has determined that no one else is available to serve as the AR.	E&P PT 02-15

B-1450.2	<b>Non-English Speaking Interpretive Requests</b> -Third paragraph updated to clarify completed Form 2034-WG will now be forwarded to the designated individual in each district office. These forms will no longer be forwarded to Eligibility and Payments in Central Office.	E&P IM 31-14
C-100	<b>Table of Contents</b> -Update Table of Contents to remove sections which have been obsoleted due to numerous policy and program changes. C-160 and C-170 should read “Reserved”	
C-110	<b>Input Cut-Off Dates for Monthly Benefits</b> -Cut-off schedule for 2015 updated with updated dates.	
C-115	<b>NOMADS Adverse Action Dates</b> -Adverse dates updated for 2015. “NOMADS” removed as adverse is for all eligibility systems and is not specific to NOMADS.	
C-140	Update the TANF Needs Standards Chart with the new 2015 Federal Poverty Level increases effective 4/1/15.	
C-170	<b>Sneede-Kizer Sub Assistance Unit (SU) Example Charts</b> -Section obsoleted as all medical assistance policy is now found in the Medical Assistance Manual. In addition Sneede-Kizer budgeting is no longer used when determining medical eligibility.	
C-180	<b>TANF Budgeting Steps</b> -All reference to CHAP removed from section. All medical assistance program policy is now located in the Medical Assistance Manual.
