## NEVADA STATE DIVISION OF WELFARE AND SUPPORTIVE SERVICES (DWSS) ELECTRONIC BENEFITS TRANSFER (EBT) CARD ISSUANCE AUTHORIZATION

I have received training on the use of my Electronic Benefits Transfer (EBT) card and Personal Identification Number (PIN), and I understand: I am responsible for safeguarding my EBT card and PIN. If either my TANF cash or SNAP benefit account is accessed by me, an authorized representative, or any other person in possession of my EBT card and PIN, the transaction is considered authorized and the benefits will not be replaced. I must report a lost or stolen EBT card immediately by calling the FIS ebtEDGE Customer Service Hotline at 1-866-281-2443. Neither my TANF cash nor SNAP benefits will be replaced for the time period between the loss/theft of my EBT card and PIN, and the time I report the loss/theft to the FIS ebtEDGE Customer Service Hotline (1-866-281-2443). There is no restriction on the number of times I may use my EBT card. Adjustments could be made to my TANF cash or SNAP EBT account to correct system errors. I understand the state will remove or expunge any benefits remaining in my EBT account past the intended period of use, and those benefits will not be restored.
