Megan O'Farrell:

I'd like to thank everyone who participated today especially those of you that shared from vulnerable places. Those stories need to be told to help folks in similar position to what you have experienced. I appreciate you using your experiential knowledge to help educate those of us who have not experienced these kinds of things. I hope you know how impactful it is for those of us who are learning from you how to be better supporters and advocates. I also wanted to say thank you to the presenters who are trying to put together the data collection. Michele and Patty, I'm sorry I don't remember your last names or I would give a more formal thank you. I did want to touch and what Danielle said about follow up. There is a need for follow up. As Danielle said putting someone in a house isn't the end game. It's a starting point and I think a lot of times in our management practices and in our outreach we stop there and it is doing a huge disservice to folks. It reinforces this idea that the only problem is the visibility and the visibility for folks that don't want to see this. Having that follow up information on where did they go and what are

they doing and how long are they off the streets? Saying people are off the streets is very loose and doesn't translate to what it means for folks to transition into whatever versions of their lives they are trying to strive for. We would really benefit from having that information. The low barrier is very important, but we need to have these stages where we are following up with folks when they move into these higher barrier positions. So they do feel supported and have the resources to continue to stay in those spaces instead of relaxing back into a situation of homelessness.

#### Michele Fuller-Hallauer:

I'd like to thank this Council for agendizing and hearing stories from those who have lived experience. I feel its very important that you hear from folks that have lived experience, from folks that are providing services and the challenges that we have and gaps in the system. I commend you for recognizing that and agendizing that. Thank you to those who shared your stories and sharing a piece of yourself with us and being vulnerable. I really appreciate that and as being a system leader here in Nevada, I know that its not always easy to share on a public forum and appreciate that you stepped up and have done that. If you or your peers are in Southern Nevada and want to participate in the CoC working groups, reach out to me. To give voice to the work we are doing and we need you.

#### **Norris Scott:**

I want to thank Council for their participation and desire to want to help and give back. Everyone needs to find our part and do our part.

#### Ana Maria Hernandez:

I just want to say thank you to everyone who shared their stories. The first step in bringing about change is talking about the hardship that we see. Everyone who shared was very courageous in sharing what they
