Chair Tim Robb:

Item number three – discussion and possible approval of the minutes from the previous council meeting on April 25th, 2024. Does anybody have any concerns with the minutes from the last meeting? I would entertain a motion to approve those minutes.

Agenda Item IV. [Update Discussion on the Progress of AB 310 – Stephen Aichroth]

Chair Tim Robb:

Item number four – update discussion on the progress of AB 310 from Administrator Aichroth. Go ahead sir.

Stephen Aichroth:

Thank you. Good afternoon, chair, and members of the committee. I am here to give an update on AB 310 and the progress the division has made. Draft regulations were sent back to the division from the **3** | P a g e

LCB. The file number of the regulations is RO78-24. We scheduled the public workshop on those regulations after they were returned to the division. It was held on May 16th. In attendance was the bill's sponsor, Assembly Speaker pro tempore, Daniele Monroe-Moreno. The division presented the regulations and listened to suggestions. We will continue to work with Assemblywoman Monroe-Moreno to amend the language in the bill. The next step of the state process is an adoption hearing. I, as the administrator, will adopt the language for submission to the Legislative Commission. The final language will be presented and approved at this hearing. The meeting is scheduled for June 18th. After the hearing, it will go to the Legislative Commission for approval. Assuming it's approved, we can begin to launch the program. The division has been working on a draft program design. We will be holding a roundtable on the program design. To get input from stakeholders. The date is to be determined but will occur before the adoption hearing on June 18th. Our intent is to let everyone on this board be aware of when that will occur. There are three objectives as per the bill. To increase the supply of supportive housing. Build the capacity of supportive housing industry to reduce homelessness. Evaluate the effectiveness of the intervention in Nevada. The objective one is to fund supportive housing services projects. This is not for bricks and sticks. This will be combined with the \$30 million program. To provide the support processes to those developments. Building the capacity is a \$1.5 million objective. \$700, 000 is allocated towards the evaluation and determination of the effectiveness of the funds. Those are all statutory defined. The current eligible entities for the funds include any public or private nonprofit, housing authority or local jurisdictions. The tenant eligibility is at or below 30% of the area's median income. To be eligible, a person will have to meet some criteria regarding homelessness. Such as needing medical assistance, behavioral health issues, turnover of inhome caregivers, or be at risk of homelessness. Here are the criteria for evaluation. The experience of the entity in supportive housing. The delivery and type of support that are being provided. The demographic of the tenants. The costs of providing the support services. The outcomes, geographic location, sustainability, amount of funds being leveraged with potential other sources. And any other criteria that the division determines applicable. All grant programs can be determined and modified through stakeholder engagement at the roundtable. Our current proposal is to divide the \$30 million bucket into two. One is only for supportive services at \$15 million. The other \$15 million will continue the services but can also provide some operational support. Such as rental assistance to the residents. Next is to split the capacity building into organization, training, and planning. We will do one award for the measurement and evaluation of the program. We tentatively identified the opening will be on July 1st. This is depending on when the Legislative Commission meets and approves the regulation. Once approved, the program design will be ready. We will accept applications for a month. Then, we'll be awarding within a month after. As per AB 310, we need to consult with this group in the awarding process before we make the actual award. I will present to the group the specifics of these proposals in the next meetings. I am open to questions.

Chair Tim Robb:

Is the draft publicly posted for members to check?

Stephen Aichroth:

It's not publicly posted yet. I will provide the draft to the committee secretary for the committee members to review. It will be available on our website soon.

That would be great. Please keep us posted so we can work through on the process as outlined in Assembly Bill 310. We appreciate being involved in the process and all the work that's being done.

Thank you for the opportunity to give you an update. We continue to meet monthly. We continue to work diligently on the action plan that goes with the strategic plan. The workgroups have submitted the proposed action steps for each strategic issue. We are combing through it due to some identified overlaps. We want to ensure that we provide a comprehensive plan. New members were voted in during our previous meeting. Shelly and I were honored to do the orientation for our new members last Tuesday. We will continue to get more information to you all in preparation for the next legislative session. I am open to questions or further direction.

I think it is important to elevate their voices on the work that they are doing. To provide feedback assistance. To highlight what needs to change. It would be great to invite those two groups to do a separate presentation.
