Removed definition for chronically homeless individuals as homelessness is now an exemption. Included exemptions of homeless, veterans, and individuals aged out of foster care. Updated which legislation brought about the changes and removed 12-month veterans as a discretionary exemption as they are now federally exempt.	<b>EP PT 24-23</b>	<b>13-23</b>
<b>B-471</b>	Per Fiscal Responsibility Act of 2023, updated the age of those who are subject to ABAWD requirements.	<b>EP PT 24-23</b>	<b>13-23</b>
