# **Division of Welfare** and Supportive Services (DWSS)

determines Medicaid and Nevada Check Up eligibility for low-income Nevadans. Apply online through Access Nevada at accessnevada.nv.gov

Medicaid provides free health care coverage for lowincome Nevadans, including:

- Adults between the ages of 19-64 whose household income is at or below 138% of the Federal Poverty Level (FPL) (See chart)
- Children under age 19 whose income is at or below 205% of the FPL
- Pregnant women whose household income is less than 190% of the FPL
- Parents or caretakers with income at or below 138% of the FPI
- Supplemental Security Income (SSI) recipients
- Certain Medicare beneficiaries

Nevada Check Up provides medical and dental benefits for children from birth to 18 years old. To qualify, your income must be at or below 205% of the Federal Poverty Level (See chart).

A small premium, on a quarterly basis, may be required. Checks or money orders must be sent to:

### **Other Access Nevada Programs**

- The Supplemental Nutrition Assistance Program (SNAP) helps low-income Nevadans buy nutritious food from local retailers.
- Temporary Assistance for Needy Families (TANF) is designed to help families achieve self-sufficiency through job preparation, work opportunities and support services.

Medicaid and Nevada Check Up services are provided through Managed Care Organizations (MCO) — Anthem Blue Cross and Blue Shield, Health Plan of Nevada, Molina Healthcare of Nevada, and SilverSummit Healthplan. Dental services are managed by Liberty Dental Plan. In rural areas and for some coverage groups, the Division of Health Care Financing & Policy (DHCFP) pays claims on a "fee for service" basis.

### **Nevada Health Link**

Nevada Health Link is the state's online health insurance marketplace where Nevadans can enroll in comprehensive, qualified health and dental plans. Nevada Health Link can help you find a plan that fits your medical needs and budget. You cannot be denied due to a pre-existing medical condition. Plan costs are based on the household's taxable annual income, how many people are in the household, the place of residence and if anyone in the household uses tobacco. Applicants may be eligible for tax credits and other financial assistance with their selected plans.

# Do I Qualify?

On Access Nevada, <u>accessnevada.nv.gov</u>, there is a button marked "Do I Qualify?". This is a pre-screening tool that can help determine if you may be eligible for Medicaid, Nevada Check Up, or if you may need coverage through Nevada Health Link.

# I Am Potentially Eligible. What do I do next?

After answering the questions in the pre-screener, you will be given the opportunity to continue to apply for benefits through Access Nevada.

Depending on program requirements, some documentation may be required. It would be helpful to have these documents available when you apply:

- Proof of citizenship, such as a birth certificate or permanent residency ID card.
- Social Security Card.
- Proof of income, such as copies of your 2 most recent paystubs; if self-employed, a copy of your prior year's tax return.
- Current health insurance, if applicable, with ID card.
- Current employment information, including name, address, contact name and phone number.

# What happens next?

Upon submission of an application for Medicaid or Nevada Check Up, DWSS will send a confirmation letter. The case number and PIN will be included for use with the phone system or Access Nevada "Check My Benefits." You will be able to get basic information about your benefits.

When additional information is necessary to determine eligibility, DWSS will send you a letter outlining the required information and the date it must be received. If information is not received by the date requested, the application is denied.

A Notice of Decision letter will state if your application was approved or denied. If you disagree with the determination, the letter will provide contact information on how to appeal the decision.

If you've selected a health insurance plan through Nevada Health Link, you will receive additional information from your insurance company about how to pay for and manage your plan.
