1. Call to Order by Kelly Cantrelle, Deputy Administrator: March 27, 2025, at 2:01 p.m.

2. Introduction/Purpose: Kelly Cantrelle, Deputy Administrator

Kelly Cantrelle: The Division of Welfare and Supportive Services has scheduled a Public Hearing to discuss the possible adoption of the proposed amended FY2025 Supplemental Nutrition Assistance Program Employment and Training (SNAPET) Program State Plan, as indicated on the agenda.

In-person public comment from Jessica Mahon of the Community Services Agency in Reno, Nevada: Thank you to Deputy Administrator Cantrelle, Ms. Wortman-Meshberger and the Division of Welfare and Supportive Services Team for the opportunity to express our support for the proposed amendments to the SNAP E&T State Plan.

My name is Jessica Mahon, and I am here today on behalf of Community Services Agency (CSA), a nonprofit Community Action Agency in Reno, NV. For 60 years, CSA has been serving lowincome residents of Washoe County and the surrounding rural communities with impactful programs and services aimed at reducing the impact of poverty and helping individuals and families gain self-sufficiency.

Since 2008, CSA has been a leader in the workforce development realm, helping thousands of low-income individuals in Northern Nevada gain the skills, training, and support needed to secure living wage jobs and access opportunities for career advancement. Over the past 18

months, our agency has participated in a learning cohort and community of practice with the National Community Action Partnership focused on increasing capacity for Community Action Agencies to participate in SNAP E&T as third-party providers. This provided our agency with opportunities to explore best practices for SNAP E&T services and learn how third-party providers like our agency can best support SNAP participants in gaining economic mobility.

CSA was thrilled to submit a proposal to the Nevada Division of Welfare and Supportive Services to serve as a third-party provider of SNAP E&T services, supporting an increase in the number of SNAP recipients served by the program in our region. These services will be funded through the SNAP E&T 50/50 funds without an impact on the administrative funds received by the division. Thanks to a generous commitment from our sister agency, Community Services Agency Development Corporation, CSA has secured the required 50/50 match funds for the next three program years.

Through our integrated approach, participants will receive personalized career assessments, skill development, supportive services, and direct job placement assistance to ensure they have a clear path to stable, living-wage employment. Our agency has a long history of successful collaboration with employers, training providers, and community organizations to maximize opportunities for job seekers, and we are committed to making this program a success with anticipated outcomes for participants to include Increased Job Readiness, Successful Employment and Job Retention, Vocational Skills Development, and Reduced employment barriers through the delivery of supportive services.

We believe that investing in workforce development for SNAP participants benefits not only the individuals we serve but also our local economy by preparing workers for in-demand jobs. We appreciate the opportunity to partner with the state in expanding employment and training services and look forward to making a meaningful contribution to these efforts.

- v. Increase the Job Retention Component timeframe from 30 days to 60 days.
- vi. Change the documentation requirement for the Supervised Job Seach Component to require only the job search tracking form.
- vii. Under Table G.VII, added an additional option for allowable back-up documentation when a contracted educational provider submits reimbursement requests to the division.
- viii. Updated the Screening and Referral Process to remove the requirement for eligibility staff to determine if an individual's supportive services needs exceed those allowable by state policy.
