SEM 103	Conforming changes are made to SEM 103 and Exhibit 100-1 pursuant to Assembly Bill 527 (2019) increasing the annual fee assessed never assistance custodians to \$35 for cases in which at least \$550 in child support has been disbursed.	
SEM403(E) Exhibit 400-6 (deleted) TOC 400	Minor language change to conform with OCSE form change and facilitate ADA remediation of DWSS website. Conforming changes to table of contents.	
SEM 602.19	Senate Bill 33 (2019) requires all insurers in Nevada, including life insurance companies, to report pending claims settlements to CSEP beginning January 1, 2020. Conforming changes are made to SEM Section 602.19, and additional explanatory language regarding insurance claims has been added.	
SEM 615	NRS 125B.095, the penalty statute, is repealed effective the date the new child support guidelines regulation becomes effective. Language is added explaining penalties that accrued before the repeal date are due and must be enforced pursuant to SEM 615(A). However, from the repeal effective date forward, penalties, even though court ordered, will not accrue or otherwise be enforced. Orders issued after the repeal date should not contain a penalty provision.	
SEM 615(B)(2) 615(C)	Incorporates CSEP-PP-19-01 regarding the UIFSA requirement for responding states to collect interest on behalf of initiating states in intergovernmental cases.	
SEM 600(A) SEM 616 Through SEM 617	Senate Bill 17 (2019) provides for the administrative suspension of hunting and fishing licenses in a process akin to driver's license suspension. Conforming changes are made to Support Enforcement Manual Sections 616 through 617 regarding license suspension. Minor language changes have also been made to improve clarity and readability.	
SEM600 602.14 610(E) and (F)	Minor language cleanup, typographical corrections, and contact information updates.
