SEM 107 (A)	Corrected citation regarding NRS 422.2749	
SEM 502 (E)	Revised language incorporating statutory changes. <u>Assembly Bill 95</u> of the 2017 Legislature creates a new section of Nevada Revised Statute Chapter 425 prohibiting debts for child support from being incurred by an obligor receiving TANF benefits pursuant to NRS 422A for a dependent child. Child support arrearages accrued prior to an obligor receiving TANF must be held in abeyance while the obligor is receiving benefits. This law does not apply if a court finds that the obligor is purposefully unemployed.	16-17
SEM 612	Revised language incorporating revised Federal regulations requiring states to establish guidelines for the use of civil contempt. See <u>45 CFR 303.6(c)(4)</u>	14-17
SEM 708	New text added explaining federal requirements to disburse child support payments only to custodians and certain other specified entities.	
SEM 709	Clarifies that although custodians have the right to contract with attorneys and private child support collection agencies, federal regulations do not authorize payments to be made to a custodian's attorney or contracted collection agency.
