## **DESCRIPTION OF HEADINGS**

**Locate Cases:** Cases in which the non-custodial parent (NCP) has not been identified/located. **Paternity Cases:** Cases for which paternity has not been resolved.

**Obligation Cases:** Paternity is not an issue, the non-custodial parent has been located, but no court order has been established.

**Enforcement Cases:** A court order exists and the non-custodial parent may or may not be paying.

NPLS Cases: Cases in which Nevada is providing locate-only services for another state.

# CASE TYPES

Medical Cases: Medical only cases.

**Foster Care Cases:** Child is in foster care through the Division of Child and family services. **TANF Cases:** (Temporary Assistance for Needy Families) - Custodian is receiving a cash grant from the Welfare Division.

Former Assistance Cases: Custodian receiving TANF in the past.

**W/O Perm or Cond:** Prior TANF case without permanent or conditional arrears (used with case type P).

**Non-Assistance Cases:** The custodian or non-custodial parent has submitted an application requesting child support enforcement services.

**Former Medical:** Has received Medicaid benefits in NOMADS (used with case type N). **Interstate Responding:** Out of State jurisdiction has requested Nevada to open case (used with case type N).

Quick Locate Cases: Quick Locate Cases.

**Non-IVD:** Nevada case where parties have never requested IVD services (used with case type D).

**Former IVD:** Nevada closed case where IVD services has been previously requested (used with case type D).
