## Dear State of Nevada TANF Recipients:

The State of Nevada Division of Welfare and Supportive Services (DWSS) is partnering with non-profit agencies throughout the state, utilizing American Rescue Plan Act (ARPA) Pandemic Emergency Assistance Funds (PEAF), to provide a one-time diaper bundle to children in diapers aged 5 or younger and/or pregnant mothers in at least their 6<sup>th</sup> month of pregnancy for their unborn child(ren), while supplies last.

Your household may be eligible for a PEAF diaper bundle if you:

- Have a child/children 0-5 years old who are still wearing diapers, or are a mother at least 6 months pregnant; and
- Are an active Nevada TANF recipient or eligible member of the TANF household at the time of pre-registration; and
- Have not received any other PEAF diaper bundle from any other source.

## Diaper bundles will include:

Diapers, Wipes, Diaper Rash Cream and Tote

## Please note:

- You may only register and receive one diaper bundle allotment per eligible child/pregnant
  mother and cannot register with more than one agency. Each agency has a limited number of
  diaper bundles and the bundles will only be available while supplies/sizes last.
- By pre-registering for a diaper bundle, the registrant is giving express consent for the agency
  and the Division of Welfare and Supportive Services (DWSS) to share all information provided by
  the registrant for the purpose of verifying eligibility to receive a PEAF diaper bundle and for
  coordination of services.
- Pre-registering does not confirm eligibility of a PEAF diaper bundle. Once pre-registration has
  been completed, information will be shared with the DWSS to verify eligibility for the PEAF
  bundle. Once eligibility has been determined, the agency will attempt to notify the registrant of
  their eligibility status via phone or email, and if applicable, arrange for pick-up. It is the
  responsibility of the registrant to confirm eligibility with the agency prior to the anticipated
  distribution date.
- The person picking up the diaper bundle must be an adult household member or an authorized representative currently listed on the TANF case.
- You will be required to provide proof of identity at time of receipt of the diaper bundle.

If you are a current TANF recipient and interested in receiving a diaper bundle for your eligible child(ren) you will need to pre-register with the agency closest to your physical address. Please see the agency list below and reach out using the contact information provided.
